**APPROVING THE REQUEST OF “EVN TRADING”
COMPANY TO REMOVE THE LICENSE IN ELECTRICITY
TRADING ACTIVITY NO. 179 SERIES T12, APPROVED WITH
ERE BOARD DECISION NO. 124, OF DATE 29.08.2012**

Based on articles 16; 39 point 1 and 42 point 1 letter “dh” of Law no. 43/2015, “On Power Sector”, article 121/1 of Law No. 8485, of date 12.05.1999 “Administrative Procedures Code”; article 5.1 letter “a” of the Trading License T12; article 5 of the Regulation for the Procedures of Licenses Removal, ERE Board on their 12.04.2016 meeting, after reviewing the report of License, Market and Licensee Monitoring Directory to remove the license of “EVN TRADING” company, in electricity trading activity no. 179 Series T12, approved with ERE Board of Commissioners decision no. 124, of date 29.08.2012,

Observed that:

- “EVN TRADING” company, with the official letter no. 28 protocol date 06.01.2016, has submitted at ERE a request to remove the license in Electricity Trading activity, no. 179, series T12, approved with ERE Board Decision no. 124, of date 29.08.2012.
- With decision no. 14, of date 16.02.2016, ERE decided to begin the procedures to remove the license no. 179 and series number T12 of “EVN TRADING” company,
- “EVN TRADING” company has executed any financial obligation to ERE as provided in the license conditions;
- “EVN TRADING” company has not performed any activity for which it is licensed by ERE.

For all of the above mentioned, ERE Board,

Decided:

1. To approve the request of “EVN TRADING” company, to remove license no. 179 Series T12.
2. The abrogation of ERE Board Decision No. 124, of date 29.08.2012.
3. License and Market Monitoring Directory shall inform “EVN TRADING” company for ERE Board Decision and Tariff and Prices Directory to implement this decision.

This decision enters immediately into force.
