DECISION

No. 38, dated 27.02.2020

ON

APPROVING THE “METHODOLOGY TO SET THE NATURAL GAS SALE TARIFF FROM THE SUPPLIER OF LAST RESORT”.

Based on article 13 and 90, point 11 of Law no.102/2015 “On Natural Gas Sector” as amended, article 16 of Law no. 43/2015 “On Power Sector”, as amended, article 19 and 26 of the “Regulation for ERE Organization, Operation and Procedures” approved with ERE Board Decision no. 96, dated 17.06.2016, Energy Regulator Authority (E.R.E.) Board, on their meeting dated 27.02.2020, after reviewing the report prepared by the Technical Directories Protocol no. 30/4, dated 18.02.2020 “On approving the “Methodology to set the natural gas sale tariff from the supplier of last resort”.

Observed that:

- With Decision no. 186, dated 25.11.2019, ERE Board decided “To open the procedure to review the Draft - “Methodology to set the natural gas sale tariff from the supplier of last resort”.
- Following this decision- taking, it was published on ERE website, the notification in the written media with ERE official letter protocol no. 32/58, dated 06.12.2019 and it was published in the Official Gazette no. 171 dated 16.12 .2019.
- To receive the opinions of the stakeholders regarding ERE Board Decision no. 186, dated 25.11.2019, ERE with the official letter Protocol no. 806, dated 10.12.2019 submitted to the Ministry of Infrastructure and Energy (MEI), the Competition Authority (CA); Chamber of Commerce and Industry; Consumer Association; Consumer Protection Office; Focus Customer; Albgaz company; Anio Oil & Gaz company; Phoneix Petroleum company; C.G.C company; Balkgaz company and Tap Ag Albania.
- By the end of the terms to issue or receive the opinions or proposals regarding the draft methodology to set the natural gas sale tariff from the supplier of the last resort, results that only Albgaz Company submitted its agreement with the official letter Protocol no. 14, dated 08.01.2020.

- There is no comment, remark or suggestion from the stakeholders regarding the content of the draft methodology with which ERE Board opened the procedure.
- The draft methodology to set the natural gas sale tariff from the supplier of the last resort is improved regarding its form, and fully and clearly reflects the legislation in force for the natural gas sector.

For all of the above mentioned ERE Board,

Decided:

1. To approve the “Methodology to set the natural gas sale tariff from the supplier of last resort”.
2. Legal Issues Directory shall inform the stakeholders for ERE Board Decision.

This decision enters immediately into force.

For this decision may be required its review within 7 calendar days and may be complained on Tirana Administrative Court, within 45 calendar days from the publication in the Official Gazette.

This decision shall be published on the Official Gazette
