

DECISION

NO.18 of date 21.03.2014

FOR BEGINNING THE PROCEDURES OF LICENSING "ENREL HYDRO" COMPANY IN THE ELECTRICITY PRODUCTION ACTIVITY FROM "ZEREC 1" AND "ZEREC 2" HPP'S

On the basis of article 8 point 2 letter "a", article 9 and article 13 point 1, letter "a", of Law no. 9072, of date 22.05.2003, "For Electricity Sector", as amended, article 4, point 1, letter "a", and article 10, point 1 and 3 of the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal", approved with Board of Commissioner Decision No. 108, of date 09.09.2008, article 18, point 1, letter "a", of the ERE's Practice and Procedures Regulations approved with Board of Commissioner Decision no.21, of date 18.03.2009, as amended, ERE's Board of Commissioner on its meeting of date 21.03.2014, after reviewed the application submitted by "EnRel Hydro" company, and also the report of Licensing and Market Monitoring Office and also Legal and Customer Protection Office on licensing in the electricity production activity of this company,

Observed that:

The application of "EnRel Hydro" company, partially fulfills the requirements provided by ERE on the regulation for the procedures of licensing, modification, full/partial transferring and license renewal as follows:

- The application format (article 9, point 1) is submitted and completed correctly.
- The legal, administrative and ownership documentation (article 9, point 2) is partially completed: there are completed the letters "a", "b", "c", "d", "f" and "g", and it is incomplete the letter e (The construction and administrative functioning structure of the company).
- o Financial and fiscal documentation (article 9, point 3) is partially completed: there are completed letters "a", "b", and "d", while letter "c" is incomplete (the documents that verify the ability and/or the financial support of the applicant).

The technical documentation (article 9, point 4) is partially completed: there are completed points: 4.1.1, 4.1.2, 4.1.4, 4.1.5, and it is incomplete point 4.1.3 (Technical and Graphical Documentation).

The lack of documentation that has to do with the above mention points, there will be required to the company to deposit at ERE within the deadlines set in the Regulation for the Procedures of Licensing, Modification, full/partial Transferring and License Renewal.

For all the above mentioned ERE's Board of Commissioner,

Decided:

- 1. To begin the procedures for reviewing the application of "EnRel Hydro", for licensing in the Electricity Production Activity from "Zerec 1" and "Zerec 2" HPP's
- 2. The Licensing and Market Monitoring Office is charged to notify the applicator for ERE's Board of Commissioner decision.

This decision enters immediately into force.
