No. 20, Dated 04.02.2022

ON

THE IMPLEMENTATION PROGRESS OF ERE STRATEGIC OBJECTIVES FOR 2021,
ACCORDING TO THE MEASURES PLAN FOR THE IMPLEMENTATION OF THE STRATEGIC OBJECTIVES
FOR 2021 - 2023 PERIOD AS WELL AS THE UPDATE OF THE MEASURES PLAN ON THE
STRATEGIC OBJECTIVES FOR 2022 – 2023 PERIOD

Based on article 16 and 18 of Law no. 43/2015, "On Power Sector" as amended, as well as article 15 of the *Regulation for ERE Organization, Operation and Procedures*, approved with ERE board decision no.96, dated 17.06.2016, ERE Board on their meeting dated 04.02.2022, after reviewing report Protocol no. 179/4, dated 01.02.2022, *On the implementation progress of ERE strategic objectives for 2021, according to the measures plan for the implementation of the strategic objectives for 2021 - 2023 period as well as approving the updated measures plan on the strategic objectives for 2022 – 2023 period,*

Observed that:

- ERE Board decision no. 74, dated 12.03.2021 approved ERE Strategic objectives for 2021-2023 period. This document sets the strategic objectives that ERE intends to achieve within a 3-year period, in order to fulfill the legal obligations provided in Law no.43/2015 "On Power Sector" as amended and Law no. 102/2015 "On Natural Gas Sector" as amended.
- Following, ERE Board decision no.96, dated 06.04.2021, approved the Calendar of Measures for the Implementation of ERE Strategic objectives for 2021-2023 period.
- The calendar of measures for the implementation of ERE Strategic Objectives has clearly defined the objectives, tasks, terms and responsible structures charged with the obligation to implement and continuously monitor the 3-year objectives of ERE.
- Pursuant to the provisions of the Calendar of Measures as well as point 2, of ERE board decision, no. 96, dated 06.04.2021, the Technical Directories of ERE have submitted their analysis with the tasks performed regarding the implementation of the objectives set for 2021.

Since part of the tasks are related not only to the work that is done by ERE in meeting the objectives, but also to the interaction with other institutions, there is a need to update the Calendar of Measures in order to continue working and accomplishing the tasks for the following years.

The reviewed version of the Calendar of Measures, reimposes in time, a part of the tasks and objectives of the action plan approved with ERE board decision no. 96/2021, in order to address them within 2023.

Decided:

1. To approve the updated Calendar of Measures of the Energy Regulatory Authority (ERE) for 2022-2023.

2. The updated calendar of measures, approved in point 1 of this decision, shall be subject to evaluation and review no later than January 30 of each calendar year, until its complete implementation.

3. Every structure of ERE is in charge of the implementation of this decision.

4. The Legal Directory shall inform each structure of ERE about this decision.
