THE MEETING BETWEEN THE REPRESENTATIVES OF THE ENERGY REGULATORY AUTHORITY (ERE), THE ENERGY REGULATORY OFFICE OF KOSOVO (ERO) WITH THE INTERESTED PARTIES, ON REVIEWING THE REQUEST OF THE ALBANIAN POWER EXCHANGE (ALPEX) AND TSO COMPANY "ON APPROVING THE ELECTRICITY MARKET RULES"

Within the framework of approving the Electricity Market Rules which shall serve the operation of the Power Exchange in Albania and Kosovo, the Energy Regulatory Authority welcomed on November 24, 2022, representatives from the Energy Regulatory Office of Kosovo (ERO) and held a public session together with the interested parties of both countries, such as: the Albanian Association of Electricity Suppliers (AAES), Competition Authority (AK), Free Market Supplier (FTL), Electricity Transmission, System and Market Operator of the Republic of Kosovo (KOSTT), KURUM company, Albanian Power Corporation (KESH), KESKO company and DEVOLL HYDROPOWER.

The Regulatory Authorities of Albania (ERE), Greece (RAE), and Italy (ARERA) jointly approved the rules for the first binding phase of the Trans Adriatic Pipeline (TAP) incremental capacity process.



The process is run in coordination among adjacent Transmission System Operators TAP, SNAM Rete Gas, and DESFA, according to Regulation (EU) 2017/459. It is aimed at allocating long-term incremental capacity at existing or new Interconnection Points (IPs) along TAP route and will increase gas volumes imported to Europe.

During the month of November, the ERE Board held six meetings, which resulted in twenty-four decision-making, among others, we licensed three subjects in electricity production from the photovoltaic power plants with a capacity of 2 MW each, increasing the local production power with 6 MW Green energy, three electricity trading entities and electricity supply entities; DECISIONS in which electricity sales prices are reflected, as well as decisions in which were reflected necessary changes as a result of continued cooperation with local partners or subjects licensed, and also with decisions related to institution's internal organization.

Also, part of the monthly agenda have been hearings on handling consumer's complaints.
