On 16 December 2022, it was launched, in Milan, the Balkan Energy School (BES) with its premises at the Italian regulator. BES shall promote the harmonization of the regulatory frameworks in regional level, to support the energy market development in Balkan and its integration in the European market. After the initiative undertaken by ARERA, the regulatory authorities of Albania. Bosnia Hercegovina, Montenegro and North Macedonia are the founding countries. The other regulatory authorities may become part of it during the coming months.

On the Christmas eve the Energy Regulator Authority, organized the "Day with the Children at Work". During December ERE Board held eight meetings, which lead to forty-nine decisions, among which shall be mentioned the licensing of both entities in energy production from the photovoltaic plants with capacities 2 MW each of them, increasing the domestic production power with 4 MW green energy and two entities in electricity trading as well as other decisions on which are reflected the necessary amendments as consequence of the continuous partnership with the domestic partners, or the licensed entities, but also decisions for the internal issues regarding the organization of the institution.
